1. LAYING DOWN OF WATER PIPE LINE THROUGH JALAPAHAR CANTONMENT AREA: AMRUT PROJECT: RECOMMENDATION OF:

Ref: MoD, Govt. of India, New Delhi letter No.11015/2/2012/D(land) dated 02-02-2016.

With reference to above, Darjeeling Municipality has submitted a formal application for transfer of 0.1185 acres of land in Jalapahar Cantonment for construction of reservoir under AMRUT Project. An outlet pipeline admeasuring 155 mtrs in total will pass through A1, B4 and Class 'C' land (Cantt. Road, Sy. No. 137). Darjeeling Municipality has mentioned in their proposal that the project will also serve the water needs of Jalapahar Cantonment.

As per MoD letter under reference, permission to such transfer can be issued by Competent Authority on license basis on a nominal License Fee varying from Re.1/- to Rs.1,000/- per Sq. Mtr. or Running Mtr.
